1. The content of the sponsorship announcement will be chosen by negotiation between the client and Tamworth Broadcasting Society Inc. (referred to hereafter as the station) representative. The finalised version of the sponsorship announcement will not be scheduled until approved by the client.
2. Unless the station receives a written complaint within seven (7) days of the announcement going to air, the announcement is assumed to be satisfactory. Amounts due shall be paid in accordance with the terms of this contract.
3. The sponsorship announcement must include, in addition to other material, that the client sponsors 2YOUFM 88.9 Tamworth Community radio.
4. The station's signed running sheets showing the broadcast of the announcement, shall be accepted as sufficient evidence that the announcement went to air. However, should the announcement not go to air as scheduled, for whatever reason, the station undertakes to broadcast the announcement as soon as the omission is discovered.
5. The terms of payment of Tamworth Broadcasting Society Inc. are that all contracts shall be due and payable within thirty (30) days of statement.
6. Any payment not received by the due date will render the contract liable to cancellation at the station's discretion and any outstanding amount becomes due immediately.
7. Should the client wish to cancel the contract, through no fault of the station, there will be a cancellation fee of ten (10) percent of the remaining amount due on the contract. However, by mutual agreement the contract may be cancelled provided that such cancellation shall not waive any monies due at the time of cancellation.
